Novice B & A Standard and JWW classes will run together by jump heights with division B running before division A. Excellent B & A Standard and JWW will run together by jump height with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

**Walk through:** will begin as soon as the Judge has approved the course. This will be at approximately 8:30 am. Novice and Open all heights will walk the course together prior to their class being judged. Walk through for the Excellent class will be split at the discretion of the show committee and judge.

**Judging Schedule:** Judging will begin each day at 9:00 am. Check in will begin at 8:00 am. All dogs must either: be measured, or present a height card at check-in, or have previously sent a copy of their permanent height card to the Trial Secretary. Measurement of dogs without height cards will be at approximately 8:30 am each morning.

Dogs will be judged as follows: from the lowest number in each class to the highest number.

On Saturday the jump height will be: 20, 24, 4, 8, 12, 16

On Sunday the jump height will be: 16, 12, 8, 4, 20, 24

The class order each day will be: Standard Ring – Excellent, Open, Novice; FAST demonstration JWW Ring – Excellent, Open, Novice.

Judging will rotate between the two rings with JWW starting first on Monday and Standard first on Tuesday.

**Prizes and Awards**

Rosettes will be awarded 1<sup>st</sup> – 4<sup>th</sup> place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. MACH ribbons will be available for those earning a MACH at this event. Monday: 1st Place—Hand painted wooden door hanger, 2nd-4th Places dog toys. Tuesday: 1st Place—PWCCA Pewter plates.

**Class Information, Height Division, Obstacles, Scoring**

Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

### **Move-Up Regulations**

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing within 15 minutes of the last dog completing the course.

### **Course Familiarization/Warm-ups**

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. Walk through is restricted to handlers entered in that class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

### **Notice to Exhibitors**

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Tuesday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.
